

## IIAR NATURAL REFRIGERATION CONFERENCE & EXPO/GUARDIAN ASSUMPTION OF RISK - LIABILITY WAIVER

In consideration of me and my minor child or children (collectively "Minor") being permitted by the International Institute of Ammonia Refrigeration to attend the annual Heavy Equipment Expo (herein after referred to as "Convention"), taking place in Orlando, FL, I, on behalf of myself and as parent and/or legal guardian of Minor, and on behalf of my and Minor's respective heirs, assigns, and legal representatives, agree to the following:

## I. VOLUNTARY ATTENDANCE AND ASSUMPTION OF RISK

I ASSUME, WITHOUT EXCEPTION, ANY AND ALL RISKS AND LIABILITY ARISING FROM, RESULTING FROM OR RELATED TO MINOR'S ATTENDANCE/PARTICIPATION AT THE CONVENTION, INCLUDING WITHOUT LIMITATION, BODILY INJURY INCLUDING DEATH, PROPERTY DAMAGE, OR THE RISK OF EXPOSURE TO CONTENT OR MATERIAL DISPLAYED AND/OR PRESENTED AT CONVENTION WHICH MAY BE DEEMED UNSUITABLE OR INAPPROPRIATE FOR MINORS.

## II. RELEASE and INDEMNIFICATION

I hereby voluntarily RELEASE and forever discharge IIAR, its exhibitors, sponsors, the venues where Convention will be held and all other persons or entities acting in any capacity on their behalf during Convention, and their respective successors, assigns, officers, directors, employees, agents and volunteers, (hereinafter severally and jointly referred to as "IIAR") from any and all claims, causes of action, injuries, damages of any nature, or any cost or expense incurred, caused by, or arising out of directly or indirectly, of Minor's attendance at Convention, including all transportation services provided by or arranged by IIAR to and from the Convention venue. This release shall include, but not be limited to, those claims, causes of action, injuries, or damages from bodily injury, including death, or property damage, whether or not incurred, caused by, or arising out of, directly or indirectly, the negligence, whether the sole or contributory cause of the resultant injury, death, or damage, of IIAR or their respective successors, assigns, officers, directors, employees, agents or volunteers. I also agree not to sue IIAR or their respective successors, assigns, officers, directors, employees, agents or volunteers for any of the above-specified or contemplated claims, causes of action, or damages.

# III. AGREEMENT TO PAY

I AGREE TO PAY for any and all damages, which I or Minor may in any manner cause to the property of IIAR and their respective successors, assigns, officers, directors, employees, agents, exhibitors or volunteers as arising from, or related to, directly or indirectly, Minor's attendance at Convention. By signing this Agreement, I acknowledge, on behalf of myself and Minor that if anyone is hurt or property is damaged, directly or indirectly, as a result, Minor's attendance at Convention, I may be found by a court of law to have waived my rights on behalf of myself and Minor to maintain a lawsuit against IIAR or their respective successors, assigns, officers, directors, employees, exhibitors, agents and volunteers on the basis of any claim from which I have released them herein.

# IV. MISCELLANEOUS

IIAR, in its sole and absolute discretion, may remove Minor from the Convention, at any time and without prior notice, if his or her behavior or presence is deemed inappropriate or problematic by IIAR. This Agreement may not be amended or modified except by a written instrument signed by both Parties.

The person signing this Agreement on behalf of his/her self and Minor, respectively, warrant that they are authorized to make the arrangements set out on behalf of his/her self and Minor, respectively, and have the authority to legally bind themselves and Minor to this Agreement as of the date and year set forth below.
